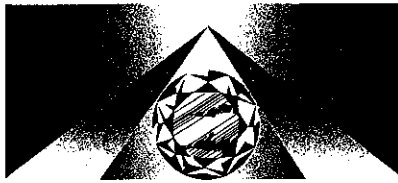
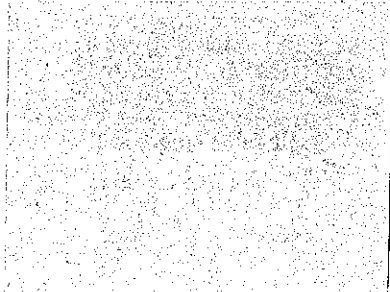

The stones are rub over/claw set in closed back settings in a central row with bead wire designs above & below, surrounded by a scalloped fluted design in turn surrounded by a filagree wire pattern oval floral design with the pearls rub over bead set on the edges. The brooch has a locket section behind with a hinged pin & hook catch. Dated circa 1850, in slightly worn condition, exact replacement is improbable. 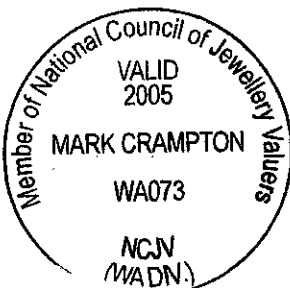

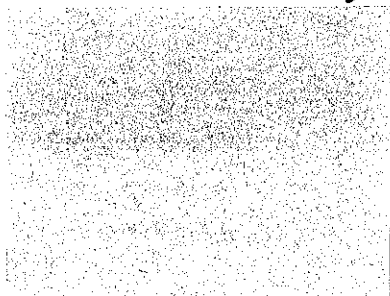

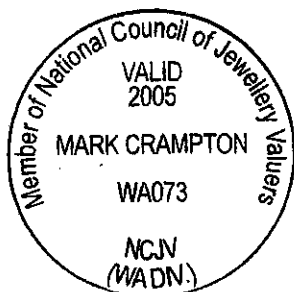
