General description

One hollow bamboo style ladies joint and snap bangle. Width =9.48 mm x 3.63 mm high.

This ring has been handcrafted using a variety of techniques, which include assembly, using hand fabricated components with traditional hand forming and finishing.

This item has been electronically and acid tested for precious metal content, these tests indicate the item to be 375 parts per thousand by weight of gold and there is a maker's mark .JC Hurst .



Clarity grading of diamonds

All clarity grading is carried out using 10 x magnifications.

Clarity grades influence the value of a diamond through rarity.

Inclusions in diamonds are graded according to size colour, number, relief and position within the stone. Internally flawless IF is the rarest. Next are the VVS 1 and 2 grades, (very very slightly included) which are "pinprick" in size. VS, grades 1 and 2 are next Inclusions in this grade are slightly larger and described as minor. SI grades 1 and 2 (slightly included) grades are next these are larger may not be visible without a lens. I (included) grade 1,2 and next; these can be seen without a lens and are the least rare.

Colour is graded by a trained grader in a controlled and specific environment. Colour grades influence the value of a diamond through rarity. D is the rarest and most expensive, followed by other rare grades of E, F and G. The grades of H and I are still white and show no colour. At J the colour is a slight tint, which becomes more obvious as the grades go through KLM.

Cut. This is described as, Ideal, class 2 A and B, class3A and B and class 4 A and B. Ideal=perfect and very precise.3B is average .4A/4B are more promotional
