RING: vintage sapphire and diamond dress , 7.50 grams

RING MOUNT... Assembled handmade, tested by XRF, stamped "18c".

A 12.4 mm tall white gold head with U shaped cradle supporting the top channel setting and with 6x small square grain settings attached to the ends at staggered levels, on a 4.85 mm parallel flat yellow gold shank with plain upswept pointed shoulders, and with an inside diameter of 19.5 mm.

The mount is in a good condition overall

NATURAL SAPPHIRE ... One is channel set, emerald cut, approx 9.5 x 6.1 x 3.9 mm in size, estimated 2.32 carats in weight, medium dark violetish blue colour, with clarity assessed as eye-clean, with very good colour quality, and 30 % brilliance, 10 % window, 60 % extinction. Noticeable chips to two corners, crown facet edges generally abraded.

** Unless otherwise stated all coloured gemstones are assumed to have undergone colour and/or clarity enhancement treatments that do not require disclosure. Only treatments for which disclosure is required, and that have been identified, are reported here. Some disclosable treatments require advanced scientific testing to identify and may therefore not be reported, Some treatments are not permanent and may require extra care.
