ZP201: PENDANT... New, modern multi-gem bird, on cord..

Total Weight = 16.25 grams.

MOUNT.... is assembled cast in 18ct rose gold, as tested by XRF metal analysis, stamped "750 0.40ct 13.90ct".

61.0 x 22.4mm in size, in the form of a peacock, comprising a central oval claw and bezel setting body, surrounded by a grain setting head, pierced grain set, pear and round claw setting feather and tail, with hanging pear-shape accents. Wire sides to underbezel and concealed bale at rear.

On a 70cm long black fabric necklet, with rose gold caps and cuffs; one is grain set to front.

SUNSTONE (Feldspar)... One is four claw set, oval cabochon cut, approx 23.5 x 13.5 x 8.5mm, reported 12.0 carats, translucent, light 'peach' orange colour with subtle aventurescence, of good quality.

NATURAL DIAMONDS... Fifty five are grain set, round brilliant cut, approx 1.2-1.4mm, reported to total 0.40 carats, with quality assessed in the setting as Very Good-Good make, G-I colour, I1-I2 clarity. One is missing.

TOURMALINES... Twenty are claw set, half are round mixed cut approx 1.5mm, and half are pear-shape mixed cut approx 5.0-6.2 x 3.1-4.1mm, estimated to total 1.90 carats, ranging in tones of light to dark, and hues including reddish purple, pink, green and orange, of medium-good colour quality.

*Tested to the extent the setting allows.

GARNET..... One is three claw set, pear-shape mixed cut, approx 7.0 x 4.95 x 3.0mm, estimated 0.70 carats, dark red, of good commercial quality.
