The Pendant:

A rounded chunky suspension bale is fixed to the heart cleft pendant encrusted centre front with 44 diamonds above the convex puffed heart with a 31 diamonds pave set within a heart motif with slightly raised border. The centre diamond is slightly larger. Verso is pierced in heart, circular, star and quarter moon shapes.

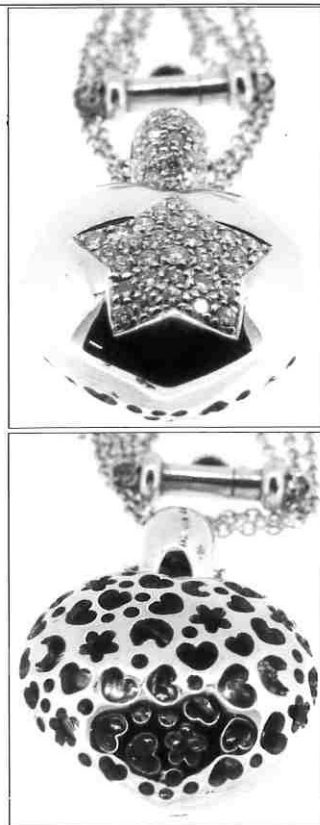
