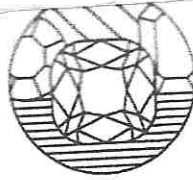

A SOLITAIRE DIAMOND RING

Cast component and hand assembled in 18 carat white gold, tested using XRF metal analysis
Hallmarks: 18K, BIRKS

The ring features one round brilliant cut diamond in a six claw pillar V shaped setting with bezel base and under-rail support. The setting is joined to a tapered band with a rounded profile, flat sides and upswept pointed shoulders. The band measures 1.30-2.20mm in width, 0.95-1.50mm in thickness and the setting measures 6.30 x 7.80mm.

Finger size: L1/2. Item weight: 2.59 grams.

Presented in good condition showing slight signs of wear.

One (1) round brilliant cut natural diamond
