18ct white gold three stone diamond ring with twenty four small side diamonds, and one diamond inside the band. The larger centre diamond is in a six claw wire setting, 5.5mm high, with a smaller diamond each side in part channel setting and a single outer claw. The band is 7.25mm wide at the centre, with a row of six graduated diamonds bead set, tapering in V design at the sides. The setting tapers to a 3.95mm wide rounded band at the sides, and 2.7mm wide x 1.25mm thick at the base. Size N1/2. The ring has a pierced back plate. Very good condition. Stamped Love and Passion with a 0.005ct RBC diamond inside the "O", 750.

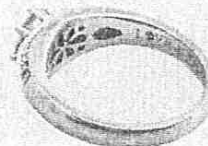
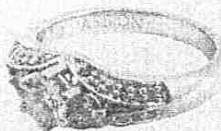
