

A 1982 KRUGERRAND COIN PENDANT AND CHAIN

Cast assembled in 22 carat gold, tested using XRF metal analysis.
Hallmarks: Frame: 375, London origin, H, FM (Chain: 375, H, BOA, SR)
Circa Period: 1982



The pendant features a 22 carat yellow gold South African Krugerrand coin, minted in 1982 with the bust of Paul Kruger, SUID-AFRIKA * SOUTH AFRICA, fine reeding along the inside edge and the reverse side with a Springbok walking right, KRUGERRAND 1982 FYNGOUD 1/10Z FINE GOLD. The coin measures 16.40mm in diameter, 1.00mm in thickness, reeded outer edge. The coin has a 9 carat yellow gold diamond cut pattern bezel with four tabs supporting the back of the setting, an outer overlapping scroll and bead pattern surround, and fitted with a tapered ribbed bale. The pendant is suspended from a 9 carat yellow gold round belcher chain with a 5.75mm bolt ring clasp. The pendant measures 25.50 x 0.70-1.1.25mm, and the chain measures 39.00cm in length and 2.14mm in width.

Pendant weight: 5.06 grams. Chain weight: 3.82 grams.

Presented in good condition showing slight signs of wear.
